

Information on Investment Management of Pension Assets of UAPF JSC held in trust by Centras Securities JSC

As of May 1, 2024, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Centras Securities JSC (hereinafter referred to as Centras Securities) amounted to KZT1,265.79 mln.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Centras Securities is shown in Table 1.

As of June 1, 2024, the weighted average yield to maturity (YTM) of debt financial instruments was 13.05% per annum.

Cash in investment accounts and reverse repo transactions

At the end of the reporting period, the cash balances in investment accounts amounted to KZT60.00 mln. Their share in the portfolio was 4.74%. At the end of the reporting period, cash balances on repo transactions amounted to KZT251.34 mln. Their share in the portfolio was 19.86%. The weighted average return on reverse repo transactions as of the reporting date was 15.23% per annum.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to KZT337.91 mln. Their share in the portfolio was 26.70%. As of the reporting date, the weighted

average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 12.76% per annum.

During the reporting period, transactions were concluded for the sale and purchase of coupon MEUKAM of the Ministry of Finance of the Republic of Kazakhstan.

Bonds of quasi-public organizations of the Republic of Kazakhstan

As of the reporting date, the weighted average yield to maturity on bonds of quasi-public organizations of the Republic of Kazakhstan amounted to 6.04% per annum in US dollars and 14.41% per annum in tenge. The current value of bonds of quasi-public organizations of the Republic of Kazakhstan at the end of the reporting month amounted to KZT182.06 mln. Their share in the portfolio was 14.39%.

Bonds of STB RK

As of the reporting date, the weighted average yield to maturity on bonds was 14.40% per annum. The current value of bonds at the end of the reporting month amounted to KZT85.32 mln. Their share in the portfolio was 6.74%.

Corporate bonds of issuers of the Republic of Kazakhstan

During the reporting period, a transaction was made to purchase coupon bonds of KMF Micro-finance Organization JSC in the amount of KZT100,000,000.00.

As of the reporting date, the weighted average yield to maturity on bonds was 17.67% per annum. The current value of the bonds at the end of the reporting month amounted to KZT100.44 mln. Their share in the portfolio was 7.94%.

Shares and depository receipts of issuers of the Republic of Kazakhstan

The current value of shares and depository receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT130.82 mln. Their share in the portfolio was 10.34%.

During the reporting period, a transaction was concluded for the sale of depository receipts of NAC Kazatomprom JSC in the amount of KZT1,058,611.53.

Equity instruments of foreign issuers (ETF Units)

The current value of equity instruments of foreign issuers (ETF Units) at the end of the reporting month amounted to KZT9.04 mln. Their share in the portfolio was 0.71%.

Shares and depository receipts of foreign issuers

The current value of shares and depository receipts of foreign issuers at the end of the reporting month amounted to KZT21.16 mln. Their share in the portfolio was 1.67%.

US government bonds

During the reporting period, there was a repayment of US government bonds in the amount of KZT80,505,000.00.

Currency structure

The investment portfolio of financial instruments by currencies in which financial instruments acquired using pension assets of the UAPF in trust management of Centras Securities are denominated is presented in Table 2.

Investment results

As a result of investment activities and changes in the market value of financial instruments, the amount of accrued investment income since the beginning of 2024 amounted to KZT73.34 mln. The return on pension assets since the beginning of 2024 has amounted to 6.14%.

The structure of accrued investment income for the specified period is presented in Table 3.

Information on compliance with the parameters of the investment declaration
