Information on Investment Management of Pension Assets of UAPF JSC held in trust by Centras Securities JSC

As of May 1, 2023, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Centras Securities JSC (hereinafter referred to as Centras Securities) amounted to KZT994.32 mln. The structure of the portfolio of financial instruments formed from pension assets held in trust by Centras Securities is shown in Table 1.

As of May 1, 2023, the weighted average yield to maturity (YTM) of debt financial instruments was 11.36% per annum.

Cash in investment accounts and reverse REPO operations

At the end of the reporting period, the cash balances on investment accounts amounted to KZT114.59 mln. Their share in the portfolio was 11.52%. At the end of the reporting period, cash balances on REPO operations amounted to KZT63.19 mln. Their share in the portfolio was 6.36%. The weighted average yield of reverse REPO transactions as of the reporting date was 16.60% per annum.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of the Government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to KZT614.57 mln. Their share in the portfolio was 61.81%.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 12.08% per annum. In the reporting period, bonds of the Ministry of Finance of the Republic of Kazakhstan were not purchased.

Bonds of quasi-public organizations of the Republic of Kazakhstan

As of the reporting date, the weighted average yield to maturity on bonds of quasi-public organizations of the Republic of Kazakhstan amounted to 6.23% per annum in US dollars. The current

value of bonds of quasi-public organizations of the Republic of Kazakhstan at the end of the reporting month amounted to KZT86.16 mln. Their share in the portfolio was 8.66%.

In the reporting period, bonds of quasi-public organizations of the Republic of Kazakhstan were not purchased.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT87.06 mln. Their share in the portfolio was 8.76%.

Equity instruments of foreign issuers (ETF Units)

The current value of equity instruments of foreign issuers (ETF Units) at the end of the reporting month amounted to KZT28.74 mln. Their share in the portfolio was 2.89%. No ETF units were purchased in the reporting period.

Currency structure

The investment portfolio of financial instruments broken down by currencies, in which financial instruments are denominated, acquired from the UAPF's pension assets in the trust management of Centras Securities, is presented in Table 2.

In the reporting period, there were no sale and purchase transactions with foreign currency on the Kazakhstan Stock Exchange

Investment results

As a result of investment activities and changes in the market value of financial instruments, the amount of accrued investment income from the beginning of 2023 amounted to KZT32.12 mln. The return on pension assets since the beginning of 2023 has been 2.98%.
