

Information on investment management of pension assets of UAPF JSC, which are in trust management of Halyk Finance Subsidiary of Halyk Bank of Kazakhstan JSC

As of February 01, 2024 pension assets (hereinafter referred to as PA) of the UAPF held in trust by Halyk Finance Subsidiary of Halyk Bank of Kazakhstan JSC (hereinafter referred to as a) amounted to **KZT20,015.69 mln.**

The structure of the portfolio of financial instruments formed from pension assets held in trust by Halyk Finance is shown in Table 1.

Reverse repo operations (no more than 90 calendar days)

The current value of reverse repo transactions for the reporting month amounted to KZT12,920.50 mln. Their share in the portfolio was 64.55%.

The weighted average return on reverse repo transactions as of the reporting date was 14.30%.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

During the reporting period, government securities of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as the government securities of the Ministry of Finance of the Republic of Kazakhstan) were not purchased as part of the portfolio.

The current value of government securities of the Ministry of Finance of the Republic of Kazakhstan for the reporting month amounted to KZT512.63 mln. Their share in the portfolio was 2.56%.

The weighted average yield of government securities of the Ministry of Finance of the Republic of Kazakhstan as of the reporting date was 12.41% per annum.

Notes of the National Bank of the Republic of Kazakhstan

During the reporting period, notes of the National Bank of the Republic of Kazakhstan (hereinafter referred to as NBRK) were not purchased as part of the portfolio. In the reporting period, NBRK notes were redeemed in the amount of 431.36 million tenge and as of the reporting date there are no NBRK notes in the portfolio.

Government securities of foreign countries

During the reporting period, US Treasury bonds were purchased in the amount of USD1.11 million at par value.

The current value of government securities of foreign countries at the end of the reporting month amounted to KZT1,308.75 mln. Their share in the portfolio was 6.54%.

The weighted average yield to maturity of government securities of foreign countries as of the reporting date was 4.12% per annum.

Bonds of international financial organizations

During the reporting period, bonds of international financial organizations (hereinafter referred to as IFOs) were not purchased as part of the portfolio.

The current value of IFO bonds at the end of the reporting month amounted to KZT19.25 mln. Their share in the portfolio was 0.10%.

The weighted average yield to maturity of IFO bonds as of the reporting date was 11.82% per annum.

Corporate bonds of resident issuers of the Republic of Kazakhstan

During the reporting period, no corporate bonds of resident issuers of the Republic of Kazakhstan were purchased as part of the portfolio.

The current value of corporate bonds of resident issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT23.26 mln. Their share in the portfolio was 0.12%.

The weighted average yield to maturity of corporate bonds of resident issuers of the Republic of Kazakhstan as of the reporting date was 10.80% per annum.

Bonds of second-tier banks of the Republic of Kazakhstan

During the reporting period, bonds of second-tier banks of the Republic of Kazakhstan (hereinafter referred to as STB RK) were not purchased as part of the portfolio.

The current value of bonds of STBs of the Republic of Kazakhstan at the end of the reporting month amounted to KZT803.99 mln. Their share in the portfolio was 4.02%.

The weighted average yield to maturity of bonds of STBs of the Republic of Kazakhstan as of the reporting date was 14.79% per annum.

Bonds of quasi-public organizations of the Republic of Kazakhstan

In the reporting period, bonds of Industrial Development Fund JSC in the amount of KZT800 mln at par were purchased as part of the portfolio.

The current value of bonds of quasi-public organizations of the Republic of Kazakhstan at the end of the reporting month amounted to KZT1,334.13 mln. Their share in the portfolio was 6.67%.

The weighted average yield to maturity of bonds of quasi-public organizations of the Republic of Kazakhstan as of the reporting date was 13.40% per annum.

Corporate bonds of foreign issuers

During the reporting period, no corporate bonds of foreign issuers were purchased as part of the portfolio.

The current value of corporate bonds of foreign issuers at the end of the reporting month amounted to KZT138.71 mln. Their share in the portfolio was 0.69%.

The weighted average yield to maturity of corporate bonds of foreign issuers as of the reporting date was 5.51% per annum.

Shares and depository receipts of issuers of the Republic of Kazakhstan

During the reporting period, shares and depository receipts of issuers of the Republic of Kazakhstan were not purchased as part of the portfolio.

The current value of shares and depository receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT92.36 mln. Their share in the portfolio was 0.46%.

Exchange Traded Funds (ETFs)

During the reporting period, shares of Exchange Traded Funds (hereinafter referred to as ETF) were purchased in the amount of KZT456.88 mln.

The current value of the ETF at the end of the reporting month amounted to KZT1,575.17 mln. Their share in the portfolio was 7.87%.

Shares and depository receipts of foreign issuers

During the reporting period, shares of Magna International Inc. were acquired. in the amount of KZT271.76 mln and shares of ASML Holding N.V. were sold. in the amount of KZT47.05 mln.

The current value of shares and depository receipts of foreign issuers at the end of the reporting month amounted to KZT266.23 mln. Their share in the portfolio was 1.33%.

Currency structure

The investment portfolio of financial instruments by currencies in which financial instruments acquired using pension assets held in trust by Halyk Finance is denominated is presented in Table 2.

Investment results

As a result of investment activities, the amount of accrued investment income since the beginning of 2024 amounted to KZT124.20 mln. The return on pension assets since the beginning of 2024 has amounted to 0.66%.

Information on compliance with the parameters of the investment declaration

The structural distribution of UAPF PAs held in trust meets the requirements of the Investment Declaration¹ for a portfolio of financial instruments formed from pension assets held in trust by

Halyk Finance. The shares of currency positions remain within the acceptable level and do not violate the requirements of the Investment Declaration for a portfolio of financial instruments formed from pension assets held in trust by Halyk Finance.
