

**INFORMATION ON INVESTMENT MANAGEMENT
OF PENSION ASSETS OF UAPF JSC, FORMED AT THE EXPENSE OF EMPLOYER'S
COMPULSORY PENSION CONTRIBUTIONS**

As of August 1, 2024, pension assets of UAPF JSC, formed at the expense of the employer's compulsory pension contributions (hereinafter referred to as ECPC PA), held in trust by the NBRK, amounted to KZT120.03 bln as of the reporting date.

The weighted average yield to maturity (YTM) of debt financial instruments in the ECPC PA investment portfolio amounted to 8.20% per annum.

The structure of the investment portfolio of ECPC PA financial instruments is presented in Table 1.

The ECPC PA investment portfolio includes only financial instruments denominated in national currency.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The main share in the ECPC PA portfolio is occupied by government securities of the Ministry of Finance of the Republic of Kazakhstan, the current value of which increased by KZT10.44 bln during the reporting month and amounted to KZT102.92 bln. Their share in the portfolio amounted to 85.75%.

In the period under review, government securities of the Ministry of Finance of the Republic of Kazakhstan were purchased in the amount of KZT11.04 bln (KZT13.10 bln at par value) with an average weighted yield of 13.41% per annum.

As of the reporting date, the average weighted yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan amounted to 12.92% per annum.

Deposits in the National Bank of the Republic of Kazakhstan

The current value of deposits in the National Bank of the Republic of Kazakhstan as of the reporting date amounted to KZT0.50 bln. Their share in the portfolio was 0.41%.

In the reporting month, as part of current liquidity management in order to maintain return for ECPC PA, investments were made in deposits of the National Bank of the Republic of Kazakhstan. The average volume of transactions amounted to KZT3.50 bln with an average weighted yield of 13.37% per annum.

Results of investment activities

The accrued investment income for ECPC PA since the beginning of management amounted to KZT1.02 bln.

As of August 1, 2024, the yield of ECPC PA for the period since the beginning of management amounted to 2.53%.

Information on compliance with investment declaration parameters

The structural distribution of ECPC PA held in trust by the National Bank of Kazakhstan complies with the requirements of the UAPF Investment Declaration¹. Information on compliance with investment limits for ECPC PA as of June 1, 2024 is presented in Table 2.
