

Information on investment management of pension assets of UAPF JSC, which are in trust management of Halyk Global Markets JSC

As of July 01, 2025, Investment portfolio of pension assets (hereinafter referred to as Investment portfolio) of UAPF JSC (hereinafter referred to as UAPF), which are in trust management of Halyk Global Markets JSC (hereinafter referred to as Halyk Global Markets), amounted to KZT 5,842.33 mln.

The structure of the portfolio of financial instruments formed from pension assets is presented in Table 1.

As of 01.07.2025, the weighted average yield on debt financial instruments denominated in tenge was 13.97% per annum. The weighted average yield on debt financial instruments denominated in US dollars was 5.51%.

Reverse repo transactions (up to 90 calendar days)

At the end of the reporting period, the total value of open Reverse REPO positions in the Investment Portfolio amounted to KZT2 166.37 mln. Their share in the portfolio was 37,08%. The average weighted yield on open Reverse REPO positions at the end of the reporting period was 15.73% per annum.

Corporate bonds of foreign issuers

In the reporting period, corporate bonds of foreign issuers were not acquired for the Investment Portfolio.

The value of corporate bonds of foreign issuers during the reporting period increased by KZT19.57 mln and at the end of the reporting period amounted to KZT726.19 mln.

As of July 1, 2025, the share of corporate bonds of foreign issuers in the portfolio amounted to 12.43%.

The average weighted yield to maturity of corporate bonds of foreign issuers at the end of the reporting period was 5.82% per annum.

Bonds of second-tier banks of the Republic of Kazakhstan

In the reporting period, bonds of second-tier banks (hereinafter referred to as STB RK) were not purchased for the Investment Portfolio.

The cost of STB RK bonds for the reporting period increased by KZT7.02 mln and at the end of the reporting period amounted to KZT600.79 mln. Their share in the portfolio as of July 1, 2025 was 10.28%.

The average weighted yield to maturity of STB RK bonds at the end of the reporting period amounted to 14.26% per annum.

Corporate bonds of issuers of the Republic of Kazakhstan

In the reporting period, corporate bonds of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of corporate bonds of issuers of the Republic of Kazakhstan during the reporting period increased by KZT4.50 mln and amounted to KZT341.72 mln at the end of the reporting period. Their share in the portfolio as of July 1, 2025 was 5.85%.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in tenge at the end of the reporting period was - 13.72% per annum.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in US dollars at the end of the reporting period was 5.16% per annum.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

In the reporting period, government securities of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as MF RK GS) were not acquired for the Investment Portfolio.

The value of MF RK GS decreased by KZT2.43 mln during the reporting period and amounted to KZT697.84 mln at the end of the reporting period. Their share in the portfolio as of July 1, 2025 was 11.94%.

The average weighted yield to maturity of MF RK GS denominated in tenge at the end of the reporting period was 16.10% per annum.

Securities with government status issued by central governments of foreign states

In the reporting period, US treasury bonds were not acquired for the Investment Portfolio and bonds were redeemed in the amount of KZT260.29 mln.

The value of securities with the status of government issued by the central governments of foreign states decreased by KZT250.14 mln during the reporting period and amounted to KZT236.05 mln at the end of the reporting period. Their share in the portfolio as of July 1, 2025 was 4.04%.

The average weighted yield to maturity of securities with the status of government issued by the central governments of foreign states at the end of the reporting period was 4.64% per annum.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

In the reporting period, shares and depositary receipts of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of shares and depositary receipts of issuers of the Republic of Kazakhstan decreased by KZT3.56 mln during the reporting period and amounted to KZT142.47 mln at the end of the reporting period. Their share in the portfolio as of July 1, 2025 was 2.44%.

Equity instruments of foreign issuers (ETF units)

In the reporting period, equity instruments of foreign issuers (ETF units) were not acquired for the Investment Portfolio.

The value of equity instruments of foreign issuers increased by KZT25.35 mln during the reporting period and amounted to KZT445.16 mln at the end of the reporting period. Their share in the portfolio as of July 1, 2025 was 7.62%.

Bonds of quasi-public organizations of the Republic of Kazakhstan

In the reporting period, bonds of quasi-public organizations of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of bonds of quasi-public organizations of the Republic of Kazakhstan during the reporting period increased by KZT4.64 mln and amounted to KZT480.60 mln at the end of the reporting period. The share of bonds of quasi-public organizations of the Republic of Kazakhstan in the Investment Portfolio as of July 1, 2025 was 8.23%.

The average weighted yield to maturity of bonds of quasi-public organizations of the Republic of Kazakhstan denominated in tenge at the end of the reporting period amounted to 10.68% per annum.

Currency structure

The structure of the Investment Portfolio by currency at the end of the reporting period is presented in Table 2.

Investment Results

As a result of investment activities, the amount of accrued investment income as of July 1, 2025 from March 15, 2021 was KZT1 513.88 mln and the amount of accrued investment income since the beginning of 2025 was KZT184.23 mln. The return on pension assets since the beginning of operations was 57.09% and since the beginning of 2025 was 3.13%, over the past 12 months from July 2024 to June 2025 amounted 13.08%.

Information on compliance with the parameters of the Investment Declaration

The structural distribution of UAPF PAs held in trust meets the requirements of the Investment Declaration for a portfolio of financial instruments formed from pension assets.¹ The shares of currency positions remain within the acceptable level and do not violate the requirements of the Investment Declaration for a portfolio of financial instruments formed from pension assets held in trust by Halyk Global Markets.
