INFORMATION ON INVESTMENT MANAGEMENT OF PENSION ASSETS HELD IN TRUST BY JUSAN INVEST JSC

As of December 01, 2022 the pension assets held in trust by Jusan Invest JSC (hereinafter - Jusan Invest) amounted to KZT 4,209.88 mln.

The structure of the investment portfolio of financial instruments formed from pension assets transferred to trust management by Jusan Invest is shown in Table 1.

As of December 01, 2022 the weighted average yield to maturity (YTM) of debt financial instruments denominated in KZT amounted to 14.64% per annum.

Exchange Traded Funds

The main share in the portfolio of pension assets transferred to trust management of Jusan Invest is occupied by shares of Exchange Traded Funds (hereinafter - ETF), which amounted to KZT1,318.17 mln. Their share in the portfolio was 31.31%.

Notes of the National Bank of the Republic of Kazakhstan

The current value of the notes of the National Bank of the Republic of Kazakhstan amounted to KZT605.77 mln. Their share in the portfolio was 14.39%.

In the reporting period, NBRK notes were redeemed in the amount of KZT1,927.22 mln.

In the reporting period, 28-day NBRK notes in the amount of KZT1,011.09 mln with a yield of 15.57% and 28-day NBRK notes in the amount of KZT609.70 mln with a yield of 15.60% were purchased.

As of the reporting date, the weighted average yield to maturity on NBRK notes denominated in tenge was 15.60% per annum.

Government Securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of government securities (hereinafter referred to as GS) of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as the MF RK) amounted to 722.26 KZT mln. Their share in the portfolio was 17.16%.

As of the reporting date, the weighted average yield to maturity on GS of the MF RK, denominated in tenge, amounted to 13.83% per annum.

Foreign government securities

The current value of government securities of foreign states amounted to KZT372.95 mln. Their share in the portfolio was 8.86%.

In the period under review, US Treasury bonds were purchased with a maturity date of November 30, 2023 and a coupon rate of 4.76%.

As of the reporting date, the weighted average yield to maturity on government securities of foreign states denominated in US dollars amounted to 4.64% per annum.

Investment results

As a result of investment activities, as well as due to the volatility of foreign exchange rates and changes in the market value of financial instruments, the amount of accrued investment income for 2022 amounted to KZT37.67 mln. The return on pension assets amounted to 3.73%.
