# Information on investment management of pension assets of UAPF JSC, which are in trust management of Halyk Global Markets JSC

As of May 01, 2025, pension assets (hereinafter referred to as PA) of UAPF JSC (hereinafter referred to as UAPF), which are in trust management of Halyk Global Markets JSC (hereinafter referred to as Halyk Global Markets), amounted to **KZT5,461.31 mln**.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Halyk Global Markets is presented in Table 1.

As of 01.05.2025, the weighted average yield on debt financial instruments denominated in tenge was 9.73% per annum. The weighted average yield on debt financial instruments denominated in US dollars was 5.35%.

#### Reverse repo transactions (up to 90 calendar days)

At the end of the reporting period, the total value of open Reverse REPO positions in the Investment Portfolio amounted to KZT1,250.83 mln. Their share in the portfolio was 22.90%. The

average weighted yield on open Reverse REPO positions at the end of the reporting period was 15.86% per annum.

# **Corporate bonds of foreign issuers**

No corporate bonds of foreign issuers were purchased for the Investment Portfolio during the reporting period.

The value of corporate bonds of foreign issuers increased by KZT12.45 mln during the reporting period and amounted to KZT779.03 mln at the end of the reporting period. The share of corporate bonds of foreign issuers in the portfolio as of May 1, 2025 was 14.26%.

The average weighted yield to maturity of corporate bonds of foreign issuers at the end of the reporting period was 5.50% per annum.

## Bonds of second-tier banks of the Republic of Kazakhstan

In the reporting period, bonds of second-tier banks (hereinafter referred to as STB RK) were not acquired for the Investment Portfolio.

The value of bonds of STB RK increased by KZT7.02 mln during the reporting period and amounted to KZT625.29 mln at the end of the reporting period. Their share in the portfolio as of May 1, 2025 was 11.45%.

The average weighted yield to maturity of bonds of STB RK at the end of the reporting period was 11.47% per annum.

## Corporate bonds of issuers of the Republic of Kazakhstan

In the reporting period, corporate bonds of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of corporate bonds of issuers of the Republic of Kazakhstan increased by KZT7.39 mln during the reporting period and amounted to KZT597.66 mln at the end of the reporting period. Their share in the portfolio as of May 1, 2025 was 10.94%.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in tenge at the end of the reporting period was -0.59% per annum.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in US dollars at the end of the reporting period was 5.34% per annum.

# Government securities of the Ministry of Finance of the Republic of Kazakhstan

In the reporting period, government securities of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as GS MF RK) were not acquired for the Investment Portfolio and bonds in the amount of KZT165.97 mln were redeemed.

The cost of GS MF RK during the reporting period decreased by KZT158.78 mln and amounted to KZT702.65 mln at the end of the reporting period. Their share in the portfolio as of May 1, 2025, was 12.87%.

The average weighted yield to maturity of the MF RK government securities denominated in tenge at the end of the reporting period was 14.81% per annum.

## Securities with government status issued by central governments of foreign states

In the reporting period, US Treasury bonds were not purchased for the Investment Portfolio and bonds in the amount of KZT128.50 mln were sold.

The value of securities with government status issued by central governments of foreign states during the reporting period decreased by KZT123.09 mln and amounted to KZT138.75 mln at the end of the reporting period. Their share in the portfolio as of May 1, 2025 was 2.54%.

The weighted average yield to maturity of securities with the status of government issued by the central governments of foreign states at the end of the reporting period was 4.49% per annum.

## Shares and depositary receipts of issuers of the Republic of Kazakhstan

In the reporting period, shares and depositary receipts of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of shares and depositary receipts of issuers of the Republic of Kazakhstan during the reporting period decreased by KZT1.96 mln and at the end of the reporting period amounted to KZT142.47 mln. Their share in the portfolio as of May 1, 2025 was 2.61%.

# **Equity instruments of foreign issuers (ETF units)**

In the reporting period, equity instruments of foreign issuers (ETF units) were not acquired for the Investment Portfolio.

The value of equity instruments of foreign issuers decreased by KZT2.98 mln during the reporting period and amounted to KZT409.83 mln at the end of the reporting period. Their share in the portfolio as of May 1, 2025 was 7.50%.

## Bonds of quasi-public organizations of the Republic of Kazakhstan

In the reporting period, bonds of quasi-public organizations of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of bonds of quasi-public organizations of the Republic of Kazakhstan during the reporting period increased by KZT1.88 mln and amounted to KZT489.44 mln at the end of the reporting period. The share of bonds of quasi-public organizations of the Republic of Kazakhstan in the Investment Portfolio as of May 1, 2025 was 8.96%.

The average weighted yield to maturity of bonds of quasi-public organizations of the Republic of Kazakhstan denominated in tenge at the end of the reporting period was 11.78% per annum.

# **Currency structure**

The structure of the Investment Portfolio by currency at the end of the reporting period is presented in Table 2.

#### **Investment results**

As a result of investment activities, the amount of accrued investment income as of May 1, 2025 from March 15, 2021 amounted to KZT1,422.22 mln and the amount of accrued investment income since the beginning of 2025 amounted to KZT92.57 mln. The return on pension assets since the beginning of operations amounted to 54.79% and since the beginning of 2025 amounted to 1.62%.
