INFORMATION ON INVESTMENT MANAGEMENT OF PENSION ASSETS HELD IN TRUST BY JUSAN INVEST JSC

As of July 01, 2023 the pension assets held in trust by Jusan Invest JSC (hereinafter - Jusan Invest) amounted to KZT3,747.38mln.

The structure of the investment portfolio of financial instruments formed from pension assets transferred to trust management by Jusan Invest is shown in Table 1.

As of July 01, 2023 the weighted average yield to maturity (YTM) of debt financial instruments denominated in tenge amounted to 14.79% per annum.

Notes of the National Bank of the Republic of Kazakhstan

The current value of the notes of the National Bank of the Republic of Kazakhstan amounted to KZT452.31 mln. Their share in the portfolio is 12.07%.

In the reporting period, NBK notes were redeemed in the amount of KZT607.06 mln.

In the period under review, 29-day NBK notes were purchased with a par value of KZT151.82 mln with a yield of 16.39% and KZT455.25 mln with a yield of 16.38%.

As of the reporting date, the weighted average yield to maturity on NBK notes denominated in tenge was 16.38% per annum.

Exchange Traded Funds

The current value of shares of Exchange Traded Funds (hereinafter - ETF) amounted to KZT1,167.93 mln. Their share in the portfolio was 31.17%.

In the reporting period, ETF units were sold in the amount of KZT154.65 mln.

Government Securities of the Ministry of Finance of the Republic of Kazakhstan

The main share in the portfolio of pension assets transferred to the trust management of Jusan Invest is occupied by government securities (hereinafter referred to as GS) of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as the MF RK), the current value of which amounted to KZT1,457.13 mln. Their share in the portfolio was 38.88%.

As of the reporting date, the weighted average yield to maturity on GS of the MF RK, denominated in tenge, amounted to 14.30% per annum.

Government securities of foreign states

The current value of government securities of foreign states amounted to KZT270.78 mln. Their share in the portfolio was 7.23%.

In the period under review, foreign government securities were sold for the amount of KZT88.91 mln.

As of the reporting date, the weighted average yield to maturity on government securities of foreign states denominated in US dollars amounted to 5.30% per annum.

Currency structure

The investment portfolio of financial instruments by currencies, in which financial instruments are denominated, acquired with pension assets transferred to Jusan Invest in trust, is presented in Table 2.

Investment Results

As a result of investment activities, as well as due to the volatility of foreign exchange rates and changes in the market value of financial instruments, the accrued investment income for 2023 amounted to KZT233.28 mln. The yield on pension assets amounted to 5.39%.
