Information on investment management of UAPF JSC pension assets in trust management of Centras Securities JSC

As of August 1, 2022, UAPF pension assets (hereinafter referred to as PA) held in trust by JSC Centras Securities " (hereinafter - Centras Securities) amounted to 952.87 million tenge.

As of 01/08/2022 weighted average yield to maturity (YTM) of debt financial instruments and REPO denominated in tenge amounted to 11.99% per annum.

Cash and reverse repos

The current value of reverse repo transactions for the reporting month amounted to 152.23 million tenge. Their share in the portfolio was 15.98%. At the end of the reporting period, the cash balances on investment accounts amounted to 178.58 million tenge. The total share of cash and claims under reverse REPO operations at the end of the reporting month amounted to 34.72%.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of the Government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to 516.53 million tenge. Their share in the portfolio was 54.21%.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 11.54% per annum.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to 87.84 million tenge. Their share in the portfolio was 9.22%.

Equity instruments of foreign issuers (ETF Units)

The current value of equity instruments of foreign issuers (ETF Units) at the end of the reporting month amounted to 17.69 million tenge. Their share in the portfolio was 1.86%. In the reporting period, the portfolio of UAPF PA in trust management of Centras Securities ETFs were not purchased.

Currency structure

Investment portfolio of financial instruments by currencies, in which financial instruments are denominated, acquired at the expense of UAPF pension assets in trust management of Centras Securities, presented in Table 2.

In the reporting period, there were no transactions of purchase and sale with foreign currency on the Kazakhstan Stock Exchange.
