Information on investment management of pension assets of UAPF JSC in trust management of BCC Invest JSC

As of August 1, 2021, pension assets (hereinafter referred to as PA) of the UAPF held in trust by BCC Invest JSC (hereinafter referred to as BCC Invest) amounted to KZT 859,025,414.

The structure of the investment portfolio of financial instruments formed at the expense of UAPF pension assets held in trust by BCC Invest is shown in Table 1

As of 01.08.2021 the weighted average yield to maturity (YTM) of debt financial instruments and repo transactions in the UAPF PA investment portfolio amounted to 10.90% per annum.

Cash and reverse REPO transactions

Until the acquisition of financial instruments in the portfolio, in accordance with the investment strategy and investment declaration, temporarily free funds are placed in reverse repo transactions, taking into account the requirements for diversification and investment limits. As of August 1, 2021, claims on reverse repo transactions amounted to KZT 134,066,819, and income on repo transactions for the period from July 1 to July 31, 2021 amounted to KZT 1,615,646. At the end of the reporting period, cash balances on investment accounts amounted to KZT 506,938 and USD 195,611.16. The total share of cash and claims on reverse repo transactions at the end of the reporting month was 25.33%.

In the reporting period, bonds of second-tier banks of the Republic of Kazakhstan were not purchased as a part of the portfolio.

As of the reporting date, the weighted average yield to maturity on bonds of second-tier banks denominated in KZT amounted to 13.28% per annum.

The current value of bonds of second-tier banks, denominated in KZT, at the end of the reporting month amounted to KZT 55,903,486. Their share in the portfolio was 6.51%.

Bonds of quasi-public organizations of the Republic of Kazakhstan

In the reporting period, bonds of Kazakhstan Stability Fund JSC (KFUSb14) in the amount of KZT 10,000,000 were purchased in the portfolio.

As of the reporting date, the weighted average yield to maturity on bonds of quasi-public organizations of the Republic of Kazakhstan, denominated in KZT, amounted to 10.45% per annum.

The current value of bonds of quasi-public organizations of the Republic of Kazakhstan, denominated in KZT, at the end of the reporting month was KZT 127,060,130. Their share in the portfolio was 14.79%.

Bonds of International Finance Organizations

During the reporting period, bonds of international financial organizations were not purchased as part of the portfolio.

As of the reporting date, the weighted average yield to maturity on bonds of international financial organizations of the Republic of Kazakhstan, denominated in KZT, amounted to 10.45% per annum.

The current value of bonds of international financial organizations of the Republic of Kazakhstan, denominated in KZT, at the end of the reporting month was KZT 65,679,250. Their share in the portfolio was 7.65%.

Corporate bonds of issuers-residents of the Republic of Kazakhstan

In the reporting period, bonds of MFO Toyota Financial Services Kazakhstan LLP (MFTFb1) in the amount of KZT 80,000,000 were purchased in the portfolio.

Thus, the current value of debt financial instruments of Kazakhstani issuers (quasi-public and corporate), as well as international financial organizations, denominated in KZT, at the end of the reporting month amounted to KZT 328,813,977. Their share in the portfolio was 38.28%.

The planned share of debt financial instruments of Kazakhstani issuers (state, quasi-state, and corporate), as well as international financial organizations, denominated in KZT, in the target structure of the UAPF PA portfolio in trust management of BCC Invest - up to 50%.

Foreign shares and depository receipts and ETFs

In the reporting period, ETFs on Dow Jones U.S. indices were acquired as part of the UAPF PA portfolio in trust management of BCC Invest. Large-Cap Value Total Stock Market Index, CRSP US Large Cap Value Index, S&P® Developed Ex-U.S. Broad Market Index, MSCI Emerging Markets Investable Market Index, WisdomTree Emerging Markets ex-State-Owned Enterprises Index which does not exceed 20%).

During the reporting period, shares of Apple Inc. were sold as part of UAPF PA portfolio in trust management of BCC Invest upon reaching the take-profit limit (profit fixing).

The current ETF value at the end of the reporting month amounted to KZT 252,627,523, the share in the portfolio is 29.41%.

The current value of shares and depositary receipts of foreign issuers amounted to KZT 59,984,207. Their share in the portfolio was 6.98%.

The planned share of ETFs, shares and depository receipts of foreign issuers in the target structure of the UAPF PA portfolio in trust with BCC Invest is up to 49%.

Currency structure

The investment portfolio of financial instruments by currencies, in which financial instruments are denominated, acquired from the pension assets of the UAPF in trust with BCC Invest, is presented in Table 2.

In the reporting period, purchase and sale transactions with foreign currency on the Kazakhstan Stock Exchange were concluded for the acquisition of USD 250,000.00.

Investment results

As a result of investment activities, the amount of accrued investment income amounted to KZT 16.55 mln. The return on pension assets was 2.77%.

Most of the accrued investment income was attributable to interest on reverse repo transactions and gains from foreign currency revaluation.

The structure of accrued investment income for the specified period is presented in Table 3.
