# Information on Investment Management of Pension Assets of UAPF JSC

As of May 1, 2021, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Halyk Global Markets JSC (hereinafter referred to as Halyk Global Markets) amounted to KZT 751.17 mln.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Halyk Global Markets is shown in Table 1.

As of 01.05.2021 the weighted average yield of debt financial instruments and reverse repo transactions in the investment portfolio of UAPF PA, held in trust by Halyk Global Markets, denominated in tenge, amounted to 8.92% per annum.

# Reverse Repo (no more than 90 calendar days)

The main share in the investment portfolio of UAPF PA, which is in trust management of Halyk Global Markets, is occupied by reverse repo transactions, the current value of which increased by KZT 51.04 mln and amounted to KZT 551.50 mln. Their share in the portfolio was 73.42%. The weighted average yield of reverse repo transactions in the investment portfolio of PA UAPF, which are in trust management of Halyk Global Markets, denominated in tenge, as of the reporting date amounted to 8.75% per annum.

# Bonds of the second-tier banks of the Republic of Kazakhstan.

In addition to this, the investment portfolio of UAPF PA, held in trust by Halyk Global Markets, contains debt securities, bonds of second-tier banks of the Republic of Kazakhstan, the current value of which for the reporting month amounted to KZT 50.40 mln. Their share in the portfolio was 6.71%.

In the reporting period, the purchase of bonds of Housing Construction Savings Bank Otbasy Bank JSC in the amount of KZT 49.99 mln with a yield of 10.80% per annum. The weighted average yield to maturity of debt financial instruments of STB RK in the Fund's PA investment portfolio under fiduciary management of Halyk Global Markets as of the reporting date is 10.81% per annum.

# Equity instruments of foreign issuers.

Also, in the investment portfolio of PA UAPF, which are in trust management of Halyk Global Markets, there are equity instruments of foreign issuers, the current value of which for the reporting month amounted to KZT 148.18 mln. Their share in the portfolio was 19.73%.

In the reporting period, the purchase of shares of exchange-traded investment funds Vanguard S&P 500 ETF for a total of KZT 49.37 mln, iShares 3-7 Year Treasury Bond ETF for a total of KZT 49.68 mln, SPDR S&P 500 ETF for a total of KZT 49.81 mln.

**Currency structure** 

The investment portfolio of financial instruments by currencies, in which financial instruments are denominated, acquired from pension assets held in trust by Halyk Global Markets are presented in Table 2.

In the reporting period, a transaction was made for the sale of foreign currency on the Kazakhstan Stock Exchange with the following parameters - USD345.67 thsd were purchased, the transaction rate was 430.65 tenge per one US dollar.

#### **Investment results**

As a result of investment activities, the amount of accrued investment income (as of May 01, 2021 from the beginning of activities) amounted to KZT 5.01 mln. The return on pension assets was 0.8%. The structure of accrued investment income is presented in Table 3.
