Information on investment management of pension assets of UAPF JSC, which are in trust management of Halyk Global Markets JSC

As of December 1, 2024, pension assets (hereinafter referred to as PA) of UAPF JSC (hereinafter referred to as UAPF), which are in trust management of Halyk Global Markets JSC (hereinafter referred to as Halyk Global Markets), amounted to **KZT4,665.49 mln**.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Halyk Global Markets is presented in Table 1.

As of 01.12.2024, the weighted average yield on debt financial instruments denominated in tenge was 12.41% per annum. The weighted average yield on debt financial instruments denominated in US dollars was 5.68%.

Reverse repo transactions (up to 90 calendar days)

At the end of the reporting period, the total value of open Reverse Repo positions in the Investment Portfolio was KZT497.40 mln. Their share in the portfolio was 10.66%. The weighted average yield on open Reverse Repo positions at the end of the reporting period was 15.0% per annum.

Corporate bonds of foreign issuers

In the reporting period, corporate bonds of foreign issuers were not acquired for the Investment Portfolio.

The value of corporate bonds of foreign issuers increased by KZT35.29 mln during the reporting period and amounted to KZT774.60 mln at the end of the reporting period. The share of corporate bonds of foreign issuers in the portfolio as of December 1, 2024 was 16.60%.

The average weighted yield to maturity of corporate bonds of foreign issuers at the end of the reporting period was 5.57% per annum.

Bonds of second-tier banks of the Republic of Kazakhstan

In the reporting period, bonds of second-tier banks (hereinafter referred to as STB RK) were not purchased for the Investment Portfolio.

The value of bonds of STB RK during the reporting period increased by KZT42.52 mln and amounted to KZT624.06 mln at the end of the reporting period. Their share in the portfolio as of December 1, 2024 was 13.38%.

The average weighted yield to maturity of bonds of STB RK at the end of the reporting period was 12.47% per annum.

Bonds of international financial organizations

In the reporting period, bonds of international financial organizations (hereinafter referred to as IFOs) were not acquired for the Investment Portfolio.

The cost of IFO bonds increased by KZT1.39 mln during the reporting period and amounted to KZT135.18 mln at the end of the reporting period. The share of IFO bonds in the portfolio as of December 1, 2024 was 2.90%.

The average weighted yield to maturity on IFO bonds denominated in tenge, with a fixed interest rate, at the end of the reporting period was 12.97% per annum.

Corporate bonds of issuers of the Republic of Kazakhstan

In the reporting period, corporate bonds of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of corporate bonds of issuers of the Republic of Kazakhstan increased by KZT7.63 mln during the reporting period and amounted to KZT555.67 mln at the end of the reporting period. Their share in the portfolio as of December 1, 2024 was 11.91%.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in tenge at the end of the reporting period was 12.85% per annum.

The average weighted yield to maturity of corporate bonds of issuers of the Republic of Kazakhstan denominated in US dollars at the end of the reporting period was 7.49% per annum.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

In the reporting period, government securities of the Ministry of Finance of the Republic of Kazakhstan (hereinafter referred to as MF RK GS) were not acquired for the Investment Portfolio. The value of the MF RK government securities increased by KZT13.70 mln during the reporting period and amounted to KZT924.33 mln at the end of the reporting period. Their share in the portfolio as of December 1, 2024 was 19.81%.

The average weighted yield to maturity of the MF RK government securities denominated in tenge at the end of the reporting period was 12.33% per annum.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

In the reporting period, shares and depositary receipts of issuers of the Republic of Kazakhstan were not acquired for the Investment Portfolio.

The value of shares and depositary receipts of issuers of the Republic of Kazakhstan increased by KZT2.53 mln during the reporting period and amounted to KZT146.08 mln at the end of the reporting period. Their share in the portfolio as of December 1, 2024 was 3.13%.

Equity instruments of foreign issuers (ETF units)

In the reporting period, equity instruments of foreign issuers SPDR Portfolio S&P 500 Growth ETF in the amount of KZT45.43 mln and ISHARES CORE S&P MID-CAP in the amount of KZT24.56 mln were acquired for the Investment Portfolio.

The value of equity instruments of foreign issuers (ETF units) increased by KZT79.44 mln during the reporting period and amounted to KZT409.70 mln at the end of the reporting period. Their share in the portfolio as of December 1, 2024 was 8.78%.

Bonds of quasi-public organizations of the Republic of Kazakhstan

No bonds of quasi-public organizations of the Republic of Kazakhstan were acquired for the Investment Portfolio in the reporting period.

The value of bonds of quasi-public organizations of the Republic of Kazakhstan for the reporting period decreased by KZT7.07 mln and amounted to KZT594.80 mln at the end of the reporting period. The share of bonds of quasi-public organizations of the Republic of Kazakhstan in the Investment Portfolio as of December 1, 2024 was 12.75%. The average weighted yield to maturity of bonds of quasi-public organizations of the Republic of Kazakhstan denominated in tenge at the end of the reporting period was 11.95% per annum

Investment results

As a result of investment activities, the amount of accrued investment income as of December 1, 2024 from March 15, 2021 amounted to KZT1,229.89 mln and the amount of accrued investment income since the beginning of 2024 amounted to KZT602.506 mln. The return on pension assets since the beginning of operations amounted to 49.39% and since the beginning of 2024 amounted to 14.46%.
