Information of the Pension Assets Investment Management of the **Unified Accumulative Pension Fund Joint Stock Company (UAPF JSC)**

As of December 01, 2020 UAPF JSC pension assets (hereinafter referred to as PA) under fiduciary management of the National Bank of RK (hereinafter, NBRK) amounted to KZT 12,723.19 bln¹.

Structure of UAPF PA investment portfolio is presented in Table 1.

Average yield to maturity of debt financial instruments in the Fund's PA investment portfolio as of December 01, 2020 is 7.7% including those nominated in KZT – 9.4% and nominated in foreign currency – 2.5% per annum.

Government securities of the Ministry of Finances of the Republic of Kazakhstan

The main part of UAPF PA portfolio is occupied by the Government Securities of the Ministry of Finances of RK with the current value of KZT 5,621.21 bln decreasing by KZT 14.66 bln. Their share in the portfolio amounted to 44.18%.

Within the period the Government Securities of the Ministry of Finances of RK denominated in KZT were sold in amount of KZT 36.73 bln with a value date of December 3, 2020. In the reporting month, there was also redemption in the amount of KZT 19.21 bln. There were no purchases of government securities of the ministry of finance of the republic of kazakhstan.

As of the reporting date, the average yield to maturity of KZT nominated government securities of RK in UAPF PA portfolio is 8.9% per annum, while those nominated in USD – 4.4% per annum.

Notes of the National Bank of the Republic of Kazakhstan

The current value of the notes of RK National Bank as of reporting date amounted to KZT 81.08 bln. Their share is 0.64%.

There were no sales, redemptions, and acquisitions of notes of the National Bank of the Republic of Kazakhstan.

Foreign Government Securities

The current value of Foreign Government securities for the reporting month increased by KZT 468.27 bln and amounted to KZT 1,269.85 bln. Their share in the portfolio is 9.98%.

In the period under review, US government securities were sold in the amount of KZT 157.72 bln. In the period no US government securities were redeemed.

There were US government securities acquired in amount of KZT 645.10 bln with average YTM of 0.09% per annum

As of reporting date the average weighted yield to maturity of the Foreign Government Securities in UAPF's PA portfolio came to 1.04% per annum.

Bonds of International Financial Organizations

The current value of bonds of international financial organizations for the reporting month increased by KZT 60.55 bln and amounted to KZT 488.88 bln. Their share in the portfolio was 3.84%.

In the period under review, securities of the European Bank for Reconstruction and Development were purchased in the amount of KZT 60.00 bln at par with a yield equal to inflation and a premium of 2.00% per annum.

There were no sales and redemptions of securities of international financial organizations.

The weighted average yield to maturity on bonds of international financial institutions, denominated in KZT, with a fixed interest rate was 9.8% per annum, with an indexed interest rate - inflation and premium, and in US dollars - 5.0% per annum.

Deposits in the Second-Tier Banks of the Republic of Kazakhstan

The current value of deposits in second-tier banks of RK with a weighted average maturity period of 3.78 years in the reporting month increased by KZT 0.88 bln and amounted to KZT 249.81 bln. Their share in the portfolio is 1.96%.

There were no allocations and redemptions of the deposits of STB RK.

The weighted average yield to maturity of deposits of second-tier banks of RK as of the reporting date is 9.1% per annum.

Deposits in foreign banks

The current value of deposits in foreign banks for the reporting period amounted to KZT 208.43 bln. Their share in the portfolio was 1.64%.

In the reporting month, deposits in foreign banks were repaid in the total amount of KZT 282.56 bln. In the period under review there were no allocations.

Deposits in the National Bank of RK

The current value of deposits with the National Bank of Kazakhstan as of the reporting date amounted to KZT 128.10 bln. Their share in the portfolio was 1.01%.

In the reporting month, as part of the management of current liquidity, in order to maintain the yield on pension assets, investments were made in the deposits of the National Bank of the Republic of Kazakhstan. The average volume of transactions amounted to KZT 53.33 bln with a weighted average yield of 7.87% per annum.

Corporate bonds of issuers of the Republic of Kazakhstan

The current value of corporate bonds of Kazakhstan issuers for the reporting month increased by KZT 0.26 bln and amounted to KZT 29.35 bln. Their share in the portfolio was 0.23%.

There were no purchases, redemptions, and sales of corporate bonds of RK issuers.

Bonds of quasi-public organizations of the Republic of Kazakhstan

The current value of the bonds of RK quasi-public organizations in the reporting month decreased by KZT 73.80 bln and amounted to KZT 1,779.26 bln. Their share in the portfolio amounted to 13.98%.

In the period under review, part of the bonds of the KazMunayGas National Company JSC in the amount of KZT 74.60 bln was sold as part of the buyback.

In the period under review, bonds of the Baiterek National Management Holding JSC were purchased in the amount of KZT 36.70 bln with a yield of 11.30% per annum. There were no redemptions of securities of quasi-public organizations of the Republic of Kazakhstan.

As of the reporting date, the weighted average yield to maturity on bonds of quasi-public organizations of the Republic of Kazakhstan, denominated in KZT, amounted to 10.8% per annum, in US dollars -5.20% per annum.

Bonds of the second-tier banks of the Republic of Kazakhstan

The current value of the bonds of the second-tier banks of RK increased by KZT 0.62bln and amounted to KZT 1,150.63 bln. Their share in the portfolio is 9.04%.

In the period under review, in accordance with the terms of the lending mechanism for priority projects ("The Economy of Simple Things"), Bank RBK JSC carried out a repurchase of a part of the bonds in the amount of KZT 2.27 bln. There were no purchases and redemption of bonds of STB RK.

As of the reporting date, the weighted average yield to maturity on bonds of STB RK denominated in KZT amounted to 10.1% per annum, in US dollars - 6.3% per annum.

Corporate bonds of foreign issuers

The current value of the corporate bonds of foreign issuers in the report period amount decreased by KZT 2.36 bln and amounted to KZT 6.85 bln. Their share in the portfolio amounted to 0.05%.

In accordance with the deadline set in the issue prospectus, the principal debt on Morgan Stanley bonds was repaid in the amount of KZT 2.26 bln.

Within the reporting period there were no acquisitions, sales of the corporate bonds of foreign issuers.

The weighted average yield to maturity of the corporate bonds of foreign issuers in UAPF PA portfolio as of the reporting date is 8.0% per annum.

Bonds of the quasi-public sector foreign issuers

The current value of the bonds of foreign quasi-public organizations in the reporting month decreased by KZT 5.29 bln and amounted to KZT 258.40 bln. Their share in the portfolio is 2.03%.

Within the reporting period there were no acquisitions, redemptions, and sales of the corporate bonds of foreign quasi-public organizations.

The weighted average yield to maturity of the bonds of foreign quasi-public organizations in UAPF PA portfolio is 4.6%

PPN (structured notes) of foreign issuers

The current value of PPN of foreign issuers in the reporting period came to KZT 33.68 bln. Their share in the portfolio amounted to 0.26%.

There were no acquisitions, redemptions, and sales of foreign PPN (structured notes).

Shares and depository receipts of issuers of the Republic of Kazakhstan

The current value of shares and depository receipts of RK issuers in the report period increased by KZT 8.29 bln and amounted to KZT 279.78 bln. Their share in the portfolio came to 2.20%.

Sales and purchases of shares and depositary receipts of issuers of the Republic of Kazakhstan were not carried out in the reporting period.

Shares and depositary receipts of foreign issuers

The current value of shares and depository receipts of foreign issuers in the reporting month increased by KZT 2.45 bln and amounted to 28.58 bln. Their share in portfolio amounted to 0.22%.

In the reporting period there were no sales and acquisitions of the shares and depository receipts of foreign issuers.

FX structure

UAPF PA investment portfolio of financial instruments by currencies in which the financial instruments nominated is presented in Table 2.

In the reporting period, transactions of purchase and sale with foreign currency on the Kazakhstan Stock Exchange were not concluded.

Investment results

The investment return from the beginning of the year amounted to KZT 1.2 trn in result of PA investment activity as well as due to FX volatility and change of the market value of financial instruments. The return on UAPF pension assets distributed to the accounts of contributors (beneficiaries) since the beginning of 2020 amounted to 10.16% with the inflation rate of 6.50%. Thus, the real return on the UAPF's pension assets was 3.66%.

At this, as of December 1, 2020, the return on pension assets for the past 12 months (from December 2019 to November 2020) for UAPF contributors (beneficiaries) 10.58% with inflation of 7.30%. Thus, over the past 12 months, the real return on pension assets of UAPF amounted to 3.28% The structure of investment income of the period is presented in Table 3.
