# INFORMATION ON INVESTMENT MANAGEMENT OF PENSION ASSETS HELD IN TRUST BY JUSAN INVEST JSC

As of November 01, 2024 the pension assets held in trust by Jusan Invest JSC (hereinafter - Jusan Invest) amounted to KZT9,977.82 mln.

The structure of the investment portfolio of financial instruments formed from pension assets transferred to trust management by Jusan Invest is shown in Table 1.

As of 01.11.2024, the weighted average yield to maturity (YTM) of debt financial instruments denominated in tenge was 13.18% per annum. The weighted average yield to maturity of debt financial instruments denominated in US dollars was 4.43% per annum, in euro -9.42% per annum.

# Government securities of the Ministry of Finance of the Republic of Kazakhstan

The main share in the portfolio of pension assets transferred to the trust management of Jusan Invest is occupied by government securities (hereinafter - GS) of the Ministry of Finance of the Republic of Kazakhstan (hereinafter - MF RK), the current value of which amounted to KZT3,067.07 mln. Their share in the portfolio was 30.74%.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 12.68% per annum.

# **Government securities of foreign states**

The current value of GS of foreign states amounted to KZT534.06 mln. Their share in the portfolio amounted to 5.35%.

As of the reporting date, the average weighted yield to maturity on GS of foreign states denominated in US dollars amounted to 4.43% per annum.

# **Bonds of international financial organizations**

The current value of bonds of international financial organizations (hereinafter referred to as IFOs) at the end of the reporting month was KZT491.40 mln. Their share in the portfolio is 4.92%.

As of the reporting date, the average weighted yield to maturity of IFO bonds was 12.25% per annum and in euro -9.42% per annum.

### **Corporate bonds of RK issuers**

The current value of corporate bonds of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT600.00 mln. Their share in the portfolio is 6.01%.

As of the reporting date, the weighted average yield to maturity of corporate bonds of Kazakhstan issuers amounted to 17.25% per annum.

# Bonds of second-tier banks of the Republic of Kazakhstan

The current value of bonds of second-tier banks of the Republic of Kazakhstan (hereinafter referred to as STB RK) at the end of the reporting month amounted to KZT1,176.68 mln. Their share in the portfolio is 11.79%.

As of the reporting date, the weighted average yield to maturity of bonds of STBs of the Republic of Kazakhstan amounted to 13.38% per annum.

# Bonds of quasi-public organizations of the Republic of Kazakhstan

The current value of bonds of quasi-public organizations of the Republic of Kazakhstan at the end of the reporting month was KZT394.32 mln. Their share in the portfolio is 3.95%.

As of the reporting date, the average weighted yield to maturity of bonds of quasi-public organizations of the Republic of Kazakhstan was 12.19% per annum.

#### **Corporate bonds of foreign issuers**

The current value of corporate bonds of foreign issuers at the end of the reporting month was KZT849.55 mln. Their share in the portfolio 8.51%.

As of the reporting date, the average weighted yield to maturity of corporate bonds of foreign issuers was 12.68% per annum

#### Shares and depositary receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan amounted to KZT210.30 mln. Their share in the portfolio amounted to 2.11%.

## **Exchange Traded Funds units**

The current value of Exchange Traded Funds units (hereinafter referred to as ETF) amounted to KZT2,266.27 mln. Their share in the portfolio amounted to 22.71%.

# **Currency structure**

The investment portfolio of financial instruments by currencies in which the financial instruments acquired at the expense of pension assets transferred to the trust management of Jusan Invest are denominated is presented in Table 2.

As a result of investment activities, the accrued investment income for 2024 amounted to KZT1,090.54 mln. The return on pension assets since the beginning of the year was 12.72%. The structure of accrued investment income is presented in Table 3.
