# Information on Investment Management of Pension Assets of UAPF JSC held in trust by Centras Securities JSC

As of April 1, 2024, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Centras Securities JSC (hereinafter referred to as Centras Securities) amounted to KZT1,187.67 mln.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Centras Securities is shown in Table 1.

As of April 1, 2024, the weighted average yield to maturity (YTM) of debt financial instruments was 11.16% per annum.

#### Cash in investment accounts and reverse repo transactions

At the end of the reporting period, the cash balances in investment accounts amounted to KZT23.67 mln. Their share in the portfolio was 1.99%. At the end of the reporting period, cash balances on repo transactions amounted to KZT327.13 mln. Their share in the portfolio was 27.54%. The weighted average return on reverse repo transactions as of the reporting date was 15.09% per annum.

#### Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to KZT353.43 mln. Their share in the portfolio was 29.76%. As of the reporting date, the weighted

average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 11.72% per annum.

## Bonds of quasi-public organizations of the Republic of Kazakhstan

As of the reporting date, the weighted average yield to maturity on bonds of quasi-public organizations of the Republic of Kazakhstan amounted to 5.77% per annum in US dollars and 15.92% per annum in tenge. The current value of bonds of quasi-public organizations of the Republic of Kazakhstan at the end of the reporting month amounted to KZT185.42 mln. Their share in the portfolio was 15.61%.

#### **Bonds of STB RK**

As of the reporting date, the weighted average yield to maturity on bonds was 14.64% per annum. The current value of bonds at the end of the reporting month amounted to KZT83.14 mln. Their share in the portfolio was 7.00%.

#### Shares and depository receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT102.26 mln. Their share in the portfolio was 8.61%.

During the reporting period, transactions were made to purchase common shares of Air Astana JSC.

## **Equity instruments of foreign issuers (ETF Units)**

The current value of equity instruments of foreign issuers (ETF Units) at the end of the reporting month amounted to KZT9.26 mln. Their share in the portfolio was 0.78%.

#### Shares and depositary receipts of foreign issuers

The current value of shares and depositary receipts of foreign issuers at the end of the reporting month amounted to KZT22.68 mln. Their share in the portfolio was 1.91%.

#### **US** government bonds

The current value at the end of the reporting month amounted to KZT80.68 mln. Their share in the portfolio was 6.79%.

#### **Currency structure**

The investment portfolio of financial instruments by currencies in which financial instruments acquired using pension assets of the UAPF in trust management of Centras Securities are denominated is presented in Table 2.

#### **Investment results**

As a result of investment activities and changes in the market value of financial instruments, the amount of accrued investment income since the beginning of 2024 amounted to KZT51.75 mln. The return on pension assets since the beginning of 2024 has amounted to 4.45%.

The structure of accrued investment income for the specified period is presented in Table 3.
