# INFORMATION ON INVESTMENT MANAGEMENT OF PENSION ASSETS OF UAPF JSC, FORMED AT THE EXPENSE OF EMPLOYER'S COMPULSORY PENSION CONTRIBUTIONS

As of March 1, 2024, pension assets of UAPF JSC, formed at the expense of the employer's compulsory pension contributions (hereinafter referred to as ECPC PA), held in trust by the NBRK, amounted to KZT18.50 bln as of the reporting date. The weighted average yield to maturity (YTM) of debt financial instruments in the ECPC PA investment portfolio amounted to 12.19% per annum.

The structure of the investment portfolio of ECPC PA financial instruments is presented in Table 1.

The ECPC PA investment portfolio includes only financial instruments denominated in national currency.

## Government securities of the Ministry of Finance of the Republic of Kazakhstan

The main share in the ECPC PA portfolio is occupied by government securities of the Ministry of Finance of the Republic of Kazakhstan, the current value of which was KZT 3.37 bln. Their share in the portfolio was 72.26%.

In the period under review, government securities of the Ministry of Finance of the Republic of Kazakhstan were purchased in the amount of KZT13.37 bln (KZT15.25 bln at par value) with a weighted average yield of 12.15% per annum.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan amounted to 12.19% per annum.

#### **Investment results**

The amount of accrued investment income under ECPC PA since the beginning of 2024 amounted to KZT14.58 mln.

As of March 1, 2024, the ECPC PA yield was 0.11%.

#### <u>Information on compliance with investment declaration parameters</u>

The structural distribution of ECPC PAs held in trust by the National Bank of Kazakhstan complies with the requirements of the UAPF Investment Declaration<sup>1</sup>. Information on compliance with investment limits under the ECPC PA as of March 1, 2024 is presented in Table 4.
