

Information on Investment Management of Pension Assets of UAPF JSC held in trust by Centras Securities JSC

As of November 1, 2021, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Centras Securities JSC (hereinafter referred to as Centras Securities) amounted to KZT 572.98.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Centras Securities is shown in Table 1.

As of 01.11.2021 the weighted average yield to maturity (YTM) of debt financial instruments denominated in tenge amounted to 10.10% per annum

Funds in investment accounts

At the end of the reporting period, cash balances on investment accounts amounted to KZT 0.05 mln. The share of the funds at the end of the reporting month was 0.01%.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of Government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to KZT 496.66 mln. Their share in the portfolio was 86.68%.

In the reporting month, government securities of the Ministry of Finance of the Republic of Kazakhstan were purchased in the amount of 28.28 mln tenge.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 10.10% per annum.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT 76.27 mln. Their share in the portfolio was 13.31%.

In the reporting period, ordinary shares of the issuer KCell JSC and Halyk Savings Bank of Kazakhstan JSC were purchased in the investment portfolio.

Currency structure

The investment portfolio of financial instruments broken down by currencies, in which financial instruments are denominated, acquired from the UAPF's pension assets in the trust management of Centras Securities, is presented in Table 2.

In the reporting period, there were no sale and purchase transactions with foreign currency on the Kazakhstan Stock Exchange.

Investment results

As a result of investment activities and changes in the market value of financial instruments, the amount of accrued investment income amounted to KZT 40.69 mln. The return on pension assets was 8.45%.
