

**INFORMATION ON INVESTMENT MANAGEMENT OF PENSION ASSETS HELD IN TRUST
BY JUSAN INVEST JSC**

As of 01.08.2021 pension assets held in trust by Jusan Invest JSC (hereinafter - Jusan Invest) amounted to KZT 2,062.46million.

The structure of the investment portfolio of financial instruments formed from pension assets transferred to trust management by Jusan Invest is shown in Table 1.

As of 01.08.2021 the weighted average yield to maturity (YTM) of debt financial instruments denominated in KZT amounted to 9.11% per annum .

Shares of Exchange Traded Funds

The main share in the portfolio of pension assets transferred to trust management of Jusan Invest is occupied by Exchange Traded Funds (hereinafter - ETF), the current value of which at the end of the reporting month amounted to KZT 948.38 mln. Their share in the portfolio was 45.98%.

Within the reporting period, the following ETFs were acquired:

VanEck Vectors Gold Miners ETF in amount of KZT 34.60 mln;

Fidelity MSCI Real Estate Index ETF in amount of KZT 28.06 mln;

Vanguard S&P 500 ETF in amount of KZT 26.03 mln;

SPDR MSCI AWCI ex-US ETF in amount of KZT 23.79 mln;

Schwab Emerging Markets Equity ETF in amount of KZT 23.51 mln;

iShares Core S&P 500 ETF in amount of KZT 18.02 mln;

Schwab Fundamental U.S. Large Company Index ETF in amount of KZT 4.45 mln;

iShares MSCI Global Gold Miners ETF in amount of KZT 4.39 mln.

Notes of the National Bank of the Republic of Kazakhstan

The current value of the notes of the National Bank of the Republic of Kazakhstan (hereinafter - the NBRK) amounted to KZT 739.36 mln. Their share in the portfolio was 35.85%.

In the reporting period, 28-day NBRK notes were purchased in the amount of KZT 50.31 mln with a yield of 8.10%.

In the reporting month, there were no sales and redemptions.

As of the reporting date, the weighted average yield to maturity on NBRK notes denominated in tenge amounted to 8.76% per annum.

Government Securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of government securities of the Ministry of Finance of the Republic of Kazakhstan (hereinafter - the MF RK) amounted to KZT 373.34 mln. Their share in the portfolio was 18.10%.

In the reporting period, there were acquired GS MF RK of 2027 year of redemption in amount of KZT 49.20 mln with yield to maturity of 10.14%.

There were no sales and redemptions in the period

As of the reporting date, the weighted average yield to maturity on the government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 9.81% per annum

REPO

In the reporting month, weekly reverse REPOs were opened with a basket of government securities (hereinafter - GS) in the total volume of KZT 65.01 mln with an average yield of 8.42% and one-day reverse REPOs with a basket of government securities in the total volume of KZT 473.06 mln with an average yield 8.33%.

Currency structure

The investment portfolio of financial instruments broken down by currencies, in which financial instruments purchased using pension assets transferred to trust management by Jusan Invest are denominated, is presented in Table 2.

Investment Results

As a result of investment activities, as well as due to the volatility of foreign exchange rates and changes in the market value of financial instruments, the amount of accrued investment income amounted to KZT 38.22 mln. The return on pension assets was 4.13%

Information on Compliance with the Parameters of the Investment Declaration

The structural distribution of pension assets held in trust by Jusan Invest complies with the requirements of the Investment Declaration for Trust Management of Pension Assets². The shares of foreign exchange positions remain within the acceptable level and do not violate the requirements of the Investment Declaration on trust management of pension assets. Information on compliance with investment limits for pension assets held in trust by Jusan Invest as of August 1, 2021 is presented in Table 5.
