

Information on Investment Management of Pension Assets of UAPF JSC held in trust by Centras Securities JSC

As of April 1, 2022, pension assets (hereinafter referred to as PA) of the UAPF held in trust by Centras Securities JSC (hereinafter referred to as Centras Securities) amounted to KZT 867.27 mln.

The structure of the portfolio of financial instruments formed from pension assets held in trust by Centras Securities is shown in Table 1.

As of April 01, 2022 weighted average yield to maturity (YTM) of debt financial instruments and REPO denominated in tenge amounted to 12.49% per annum.

Cash in investment accounts

At the end of the reporting period, the cash balances on investment accounts amounted to KZT29.29 mln. The share of cash at the end of the reporting month was 3.38%.

Government securities of the Ministry of Finance of the Republic of Kazakhstan

The current value of the Government securities of the Ministry of Finance of the Republic of Kazakhstan, which occupy the main share in the portfolio, at the end of the reporting month amounted to KZT547.31 mln. Their share in the portfolio was 63.11%.

As of the reporting date, the weighted average yield to maturity on government securities of the Ministry of Finance of the Republic of Kazakhstan, denominated in tenge, amounted to 11.04% per annum.

Bonds of quasi-public organizations of the Republic of Kazakhstan

In the reporting period, the issuer's Eurobonds of Development Bank of Kazakhstan JSC were purchased.

As of the reporting date, the weighted average yield to maturity on bonds of quasi-state organizations of the Republic of Kazakhstan, denominated in tenge, was 18.00% per annum. The current value of bonds of quasi-public organizations of the Republic of Kazakhstan, denominated in tenge, at the end of the reporting month amounted to KZT143.66 mln. Their share in the portfolio was 16.56%.

Shares and depositary receipts of issuers of the Republic of Kazakhstan

The current value of shares and depositary receipts of issuers of the Republic of Kazakhstan at the end of the reporting month amounted to KZT102.88 mln. Their share in the portfolio was 11.86%.

In the reporting period, ordinary shares of the issuer Kaztransoil JSC were purchased.

ETF

The current value of equity instruments of foreign issuers (ETF shares) at the end of the reporting month amounted to KZT44.14 mln. Their share in the portfolio was 5.09%. During the reporting period, the purchase of ETF units of Schwab Short-Term U.S Treasury ETF issuers was made.

Currency structure

The investment portfolio of financial instruments broken down by currencies, in which financial instruments are denominated, acquired from the UAPF's pension assets in the trust management of Centras Securities, is presented in Table 2.

In the reporting period, there were no sale and purchase transactions with foreign currency on the Kazakhstan Stock Exchange

Investment results

As a result of investment activities and changes in the market value of financial instruments, the accrued investment income amounted to KZT (-5.22) mln. The yield on pension assets amounted to (-0.72%).

The structure of accrued investment income for the specified period is presented in Table 3.
